1	Be it enacted by the Senate and House of Representa
2	tives of the United States of America in Congress assembled
3	SECTION 1. SHORT TITLE.
4	This Act may be cited as the "Biological Intellectua
5	Property Protection Act of 2025".
6	SEC. 2. SENSE OF CONGRESS.
7	It is the sense of Congress that—

1	(1) the People's Republic of China is con-
2	ducting a systematic campaign to access and exploit
3	sensitive United States data and intellectual prop-
4	erty to modernize its military, intelligence, and other
5	security apparatuses, enable human rights abuses,
6	and develop dual-use strategic technologies;
7	(2) access by the People's Republic of China to
8	sensitive United States data and intellectual prop-
9	erty poses grave and direct threats to United States
10	national security;
11	(3) the efforts of the People's Republic of China
12	to access such data and intellectual property are
13	supported by a military-civil fusion strategy, through
14	which the People's Republic of China increases the
15	size of its military-industrial complex by compelling
16	civilian Chinese companies and research institutions
17	to support its military and intelligence activities,
18	which results in ostensibly private and civilian com-
19	panies that access United States capital supporting
20	the modernization of the People's Liberation Army;
21	(4) the law of the People's Republic of China
22	requires that all citizens of the People's Republic of
23	China cooperate with national security priorities, en-
24	abling the modernization of the People's Liberation
25	Army, including through—

1	(A) the National Security Law of 2015,
2	which states that citizens of the People's Re-
3	public of China "shall have duties and obliga-
4	tions to maintain national security";
5	(B) the National Intelligence Law of 2017,
6	which states that "all organizations and citizens
7	shall support, assist, and cooperate with na-
8	tional intelligence work";
9	(C) the Data Security Law of 2021, which
10	states that "where a public security organ or
11	national security organ needs to obtain data for
12	the sake of national security or for investigating
13	crimes in accordance with the law the rel-
14	evant organizations and individuals shall co-
15	operate"; and
16	(D) the Counterespionage Law, revised in
17	2023, which states that citizens of the People's
18	Republic of China "have the duty to maintain
19	the security, honor and interests of the state,
20	and shall not engage in any act that endangers
21	the security, honor or interests of the state";
22	(5) the export of novel synthetic DNA and
23	RNA sequences provides insight into the designs and
24	research of biotechnology entities, leading to a high

1	potential for intellectual property theft by foreign
2	adversaries; and
3	(6) the United States should therefore control
4	the export of synthetic DNA and RNA sequences to
5	foreign adversaries.

14	"(3) Foreign entity of concern.—The
15	term 'foreign entity of concern' means—
16	"(A) a government entity of a foreign
