# HIGHLIGHTS OF THE 116TH CONGRESS

## **Serving Residents of Chester and Berks Counties**

Chrissy hosted more town halls than any other member of the PA delegation – 38 in total;
 12 in-person, 21 telephone, and 5 online.

- Her team closed 1,859 cases, resulting in \$4.8 million in direct Federal benefits payments back to constituents. That's in addition to the passports that were expedited, the packages lost in the US Postal Service system that were tracked down, the travelers stranded overseas who were helped home once borders closed due to COVID, and so much more.
- She was the first freshman member of Congress ever to be awarded the Democracy Award for Transparency and Accountability by the nonpartisan Congressional Management Foundation.



#### **Working Across the Aisle to Get Things Done**

- With nine of Chrissy's legislative initiatives becoming law all of which received support from Republicans – Chrissy was one of the most productive freshmen in the House.
- Chrissy co-founded For Country, a bipartisan caucus of military veterans now serving in Congress who work together on issues of public and national service.
- Of the 900+ votes that Chrissy took during her first term in Congress, nearly 78% were bipartisan.

# Fighting COVID's Impact

- In March of 2020, Chrissy reorganized her office to create dedicated teams with expertise on issues facing small businesses, people who were unemployed, and people not getting their stimulus payments. These teams provided rapid response help for thousands of constituents.
- After hearing from small businesses, Chrissy advocated for improvements to the Paycheck Protection Program, such as extending its duration, increasing flexibility in how it can be used, and ensuring that small lenders and minorityowned businesses can participate. Her bill to make it much easier for small businesses to get their PPP loans forgiven was signed into law.

# **Making a Difference Nationally and Regionally**

- After hearing from local farmers about the challenges of recruiting and retaining workers in year-round industries,
   Chrissy secured an update to the Farm Workforce Modernization Act
   so that it now includes special visas for year-round agriculture.
- Chrissy was a driving force behind the effort to enact historic legislation in 2019 to provide 12 weeks of paid parental leave for most Federal workers for the first time, setting the pace for other employers to do the same.
- The way the Department of Defense used to calculate financial support for military families living in high-cost regions made affording childcare difficult. Chrissy led an effort to change this, to make it easier for military families to afford childcare.
- After learning of our nation's overreliance on China for rare earth minerals used in everything from weapons systems to cell phones – Chrissy led an effort, now law, to require a national strategy for securing our country's supply.

# **DELIVERING FOR OUR COMMUNITY**

First and foremost, Chrissy's priority is always using her voice and vote to help our community. Throughout her time in Congress, when constituents have brought her ideas or problems, Chrissy has led the charge to help.





■ IMPROVING ACCESSIBILITY AND TRANSPARENCY: Chrissy committed to holding one town hall per month, and she did that. She hosted more town halls than any other member of the PA delegation – 38 in total; 12 in-person, 21 telephone, 5 online. These gatherings are an opportunity to hear updates from Washington but also to hear feedback and ideas from our community. In recognition of her efforts, the Congressional Management Foundation awarded Chrissy the Democracy Award for Transparency and Accountability, a first for any freshman member of Congress.



■ **HELPING CONSTITUENTS:** One of her team's primary functions is helping constituents navigate the oftentimes complicated landscape of Federal government benefits, contracts, permits, etc. Chrissy's entire district staff is focused on delivering results for people who contact us asking for help: in her first term, her team closed 1,859 cases and delivered nearly \$4.8 million back to our community.



• **SECURING FEDERAL FUNDING:** Chrissy worked with many local companies and organizations to help them compete for Federal grants and contracts. In her first term, her and her team's efforts helped secure more than \$16 million in Federal grant awards to local organizations.



• FIGHTING FOR JOBS AT SIKORSKY: When Sikorsky announced their plans to close the facility in Coatesville that manufactures the Presidential helicopter, Chrissy sprang to action. She immediately engaged the company's leadership to fight for the workforce and keep these jobs in our community. She authored legislation to hold back funding from the program until the Navy could explain to Congress the impact of the potential plant closure on our national security. Ultimately, Sikorsky decided to keep the plant open and Chrissy continues to fight alongside Pennsylvania's Senators and the Administration to keep this facility open.



• COMBATING THE LANTERNFLY EPIDEMIC: After learning that the spread of lanternflies, an invasive species from China, was affecting our local agricultural community, as well as hurting tourism revenues, Chrissy led a bipartisan call for robust funding to combat this pest. Working with Rep. GT Thompson (R-PA) and leaders from Penn State's Berks campus, Chrissy called on USDA to increase funding for research and education efforts and was successful in securing additional funding in the 2020 House appropriations bill.



• BUILDING OUR AGRICULTURAL WORKFORCE: Early in her tenure, Chrissy heard from employers in our community about the challenges of recruiting and retaining workers in our year-round agricultural industries, like dairy and mushroom production. She hosted the U.S. Secretary of Agriculture, Sonny Perdue, in the district for a discussion about this problem, and wrote to immigration policy leaders on the House Judiciary Committee to call for legislation. As a result, the Farm Workforce Modernization Act included special visas for year-round agriculture, and that bill passed the House with strong bipartisan support in December 2019.



• INCREASING VOTER PARTICIPATION: Continuing her commitment to secure and safe elections, Chrissy conducted a series of eight telephone and video townhalls over a period of seven weeks leading up to the November election. The series, Voting Safely in 2020, featured guests such as PA Secretary of State Kathy Boockvar and PA Attorney General Josh Shapiro, who answered questions of logistics and voting process. Reading Mayor Eddie Moran addressed questions in Spanish and a Zoom town hall featured first-time voters and college students from Lincoln University and West Chester University.



■ **DEVELOPING BUSINESS OPPORTUNITY:** Small business owners are the backbone of our economy. Recognizing the need to connect her community to available resources, Chrissy hosted webinars in Coatesville and Reading to provide entrepreneurs and business start-ups with resources in English and Spanish from the SBA and SCORE. Both cities in PA-06 are federally recognized Opportunity Zones.

# REACHING ACROSS THE AISLE

Pennsylvania's 6th district is a "purple place," and Chrissy is working hard to build relationships with colleagues from across the political spectrum to deliver for our community. In a time of extreme partisan politics, Chrissy is a leading voice in promoting civility and decency in our political discourse.

- With nine of Chrissy's legislative initiatives becoming law all of which received support from Republicans – Chrissy was one of the most productive freshmen in the House.
- Chrissy took over 900 votes during her first term in Congress; nearly 78% of them were bipartisan.
- A majority of the bills that Chrissy introduced had support from Republicans, including the Paycheck Protection Small Business Forgiveness Act, a bill that had more than 137 cosponsors, 2/3 of whom are Republicans, before it became law.
- Chrissy is a founding leader of For Country, a bipartisan caucus of military veterans now serving in Congress who are promoting public and national service as a career path. This group's ethos is rooted in integrity, civility and courage.
- Chrissy is a member of the Problem Solvers Caucus, a group of Senators and Representatives, equally split between Democrats and Republicans, who try to find common ground on the issues facing our nation.
- As part of her effort to empower women and girls, Chrissy founded two new groups: the Servicewomen and Women Veterans Caucus and the Women in STEM Caucus. Both groups have bipartisan support and have become platforms for likeminded members to work on these issues.

# **RESPONDING TO AND RECOVERING FROM COVID-19**

The COVID-19 pandemic has impacted every facet of American lives, from our health to our finances to our children's education. From the beginning of the pandemic, Chrissy and her team have worked hard to turn feedback from our community into action that can help us weather the pandemic and set the foundation for a strong recovery

- **DEDICATED EXPERT TEAMS:** For the first six months of the pandemic, Chrissy retooled her organization to create dedicated teams with expertise on issues facing our small businesses, people who were unemployed, and those who were struggling to get their stimulus payments from the IRS. These teams provided rapid response capabilities for thousands of constituents who reached out to her office looking for assistance. Additionally, when constituents were stranded overseas when the borders closed, her team assisted them until they were safely home.
- SMALL BUSINESS RELIEF: As a former entrepreneur, Chrissy knew how essential swift support for our small businesses would be as they navigated the early days of this crisis. Chrissy led the Pennsylvania delegation in a bipartisan effort to secure approval from the Small Business Administration to begin sending emergency relief to small businesses. She also authored the Easing Disruption for America's Small Contractor Act of 2020, a bill that would help small business Federal contractors weather the crisis.

Based on feedback from constituents, Chrissy advocated for improvements to the Paycheck Protection Program, such as extending its duration, increasing flexibility in how it can be used, and ensuring that small lenders and minority-owned businesses can participate. She introduced the **Paycheck Protection Small Business Forgiveness Act,** a bipartisan bill that would streamline the process for small business owners to get their loans of \$150,000 or less forgiven. This covered 82% of all small business loans but only 25% of the total funds lent. This bill became law in December 2020 as part of the COVID-19 relief package.

In addition to establishing a dedicated team to work with small business owners, Chrissy worked with the Small Business Administration, the Chester County Chamber of Business and Industry, and other stakeholders to hold multiple virtual town halls to answer small business owners' questions.



#### PUSHING FOR A NATIONAL HEALTH STRATEGY:

Early in the pandemic, Chrissy prioritized ensuring that our community has the resources we need to mitigate the spread of the virus, increase testing capacity, and handle positive cases. Chrissy led a bipartisan letter to support a national testing strategy. She helped introduce legislation to overhaul the way the **Defense Production Act** is used to stimulate the supply chain of essential medical supplies and led an effort to ensure that testing supplies are not diverted from Pennsylvania.

She also introduced the bipartisan National Public Health Corps Act of 2020, which would create a new program under Americorps to use national service volunteers to provide surge staffing capacity to communities in a public health crisis.

#### SUPPORT FOR STATE AND LOCAL GOVERNMENTS:

State and local governments stepped up to fill the gaps created by the lack of leadership from the Administration in 2020, many depleting their rainy day funds in the interest of public health. Chrissy has advocated for greater flexibility for state and local governments to use Federal funds to offset lost revenues and helped introduce the Coronavirus Relief Fund Local Government Flexibility Act to ensure funds could be used into 2021. The December 2020 COVID-19 relief package included language that would allow CARES funds to be used into 2021.

# LEADING ON NATIONAL ISSUES

Many of the issues dominating the national policy conversation are also priorities here in our community. Chrissy has focused much of her legislative efforts on what she calls the "No Duh" Agenda. This includes making health care more affordable and accessible to our community, lowering the cost of prescription drugs, improving the quality of our students' education, protecting our planet, pushing for universal background checks to combat the gun violence across our Commonwealth and country, and raising wages for working Americans.



■ PAID PARENTAL LEAVE: Like every working parent, Chrissy has struggled with how to balance raising her daughters with a successful career. One of the main challenges of any working parent is getting time off to bond with a child after they are born or adopted. Chrissy was a driving force behind the effort to enact historic legislation in December 2019 to provide 12 weeks of paid parental leave for most Federal workers for the first time, setting the pace for other American employers to do the same.



- **SMALL BUSINESSES:** As an entrepreneur who started and scaled organizations throughout her career, Chrissy is attuned to the challenges facing a small business owner and is working to ensure they have every opportunity for success. For example, after hearing from small businesses struggling with the impact of COVID-19, Chrissy created a "rapid response" team comprised of staff with expertise on resources available to small businesses. Her bipartisan legislation to make it easier for small businesses to get loan forgiveness for Paycheck Protection Program loans under \$150,000 was enacted into law.
- Chrissy also introduced bipartisan legislation requiring the Federal government to pay small business contractors faster, knowing that oftentimes slow cash flow can hinder growth. She also authored the Small Business Acquisition Transparency Act of 2019, which was enacted into law in December 2019. Previously, small businesses would compete for Federal contracts and have no feedback or ways to improve if they lost the bid. This law now requires the Federal government to explain to small business contractors why they did not successfully win a contract, so that they can improve their bids next time.



■ LOWERING THE COST OF PRESCRIPTION DRUGS: Across our community, Pennsylvanians are struggling with the high cost of prescription drugs, and many are making tough choices between taking their medicines and paying other bills. Chrissy is committed to lowering the cost of prescription drugs and increasing transparency for consumers. She delivered on this promise in December 2019 by voting for the Lower Drug Costs Now Act, which passed the House on a bipartisan basis. This bill made historic reforms including capping out-of-pocket costs for seniors, allowing the Department of Health and Human Services to negotiate directly with drug companies to lower costs, and investing hundreds of millions in research and innovation for new cures, among other things. She also cosponsored legislation to promote access to generics and to increase price transparency.



• CLIMATE CHANGE: Climate change is a real and present danger to our planet. Chrissy was proud to help secure House passage of the Climate Action Now Act and authored a successful amendment to ensure that the U.S. is using its diplomatic tools to encourage other countries to meet their climate goals under the Paris Accord. She has authored legislation to combat the threat of PFAS contamination in our drinking water, including two amendments to the annual defense bill that would fund a health study and improve coordination of research on cleaning up and replacing these chemicals. Chrissy believes we must work towards a goal of 100% net zero carbon emissions by 2050, as envisioned in the Climate Solutions Act, and she has championed investments in research that could make nuclear energy a safer and more cost-effective option.

# LEADING ON NATIONAL ISSUES



GUN SAFETY: There are commonsense gun safety reforms that can be made right now to keep our communities safer, and Chrissy has supported legislation in the House to do just that. She is a cosponsor of the Bipartisan Background Checks Act and the Assault Weapons Ban Act, as well as legislation to expand resources for victims of gun violence.



■ **JOBS AND WAGES:** There are still too many Pennsylvanians struggling to pay their bills on low, stagnant wages which lose value every year from inflation. Chrissy supports the Raise the Wage Act, a bill to increase the Federal minimum wage to \$15/hour (\$30,000/year). She is troubled also that women, and especially women of color, are underpaid relative to their male and white counterparts for the same work. She was a cosponsor of the Paycheck Fairness Act, which passed the House in 2019, to remedy that and require equal pay for equal work.



QUALITY EDUCATION: Chrissy believes that a quality early childhood education - especially investing in basic literacy and numeracy - is the foundation on which further educational and professional success is built. After teaching 11th grade chemistry in an underserved area of Philadelphia, Chrissy was struck by the idea that "you can't be what you can't see." She was a leader in introducing the Teacher Diversity and Retention Act, which aims to strengthen and expand the recruitment, training, and retention of diverse candidates into the teaching professions. She has also supported legislation to provide a more than \$100 billion investment rebuild our nation's school infrastructure.



■ ADDRESSING THE OPIOID CRISIS: Chester and Berks counties have suffered too many deaths by overdose due to the nationwide opioid epidemic. Deaths due to overdose in our community have declined over the past two years but there is more work to be done. Chrissy and PA Attorney General Josh Shapiro convened a discussion among those on the front lines of this crisis in Reading. Chrissy is also a supporter of two bills to help states like Pennsylvania which are struggling with this problem: the Opioid Workforce Act and the State Opioid Response Grant Act.



■ EQUITY AND EQUALITY: Chrissy has been committed to ensuring equality for every Pennsylvanian, regardless of gender identity, race, ethnicity, background, sexual orientation, or other categories used to discriminate. She has helped pass historic bills including the George Floyd Justice in Policing Act to address the systemic racism and build a more equitable justice system for Black Americans and the Equality Act to ensure all LGBTQ Americans are guaranteed the full protections of federal civil right laws and will extend anti-discrimination protections to LGBTQ Americans with regard to employment, education, access to credit, jury service, federal funding, housing, and public accommodation. The road to equality is long, but Chrissy is committed to actively pursuing policies that address and remedy systemic inequality across our Commonwealth and country.




# SUPPORTING OUR WARFIGHTERS AND STRENGTHENING OUR NATIONAL SECURITY

As a third generation military veteran with experience doing business on a global scale, Chrissy believes in supporting our military, veterans, and their families, as well as fighting for robust U.S. diplomatic leadership in the international community to protect our national security interests.

- Chrissy founded the bipartisan, bicameral Servicewomen and Women Veterans Caucus to support women during and after their military service. She wrote the Servicewomen's Health Transition Training Act of 2019, which was signed into law in 2019, ensuring women servicemembers have access to assistance in transitioning from the military into Veterans status that is geared towards their specific needs.
- After learning that women with military health insurance (TRICARE) did not have access to the gold standard of mammography and breast cancer screening, Chrissy led a bipartisan effort to get the Department of Defense to change its policy. Chrissy's **Better and Robust Screening Today (BRST Act)**, which requires TRICARE to cover 3D mammography, became law in January 2021.
- Chrissy worked across the aisle with Republican and former Marine Corps General, Rep. Jack Bergman (R-MI), on the bipartisan IMPROVE Act, which would direct grant funds to community organizations helping Veterans dealing with mental health challenges. This bill garnered support from more than half of the House of Representatives before it was signed into law in October 2020.
- As a STEM professional herself, Chrissy is concerned about building the pipeline of tech talent to support our national defense. She led the charge to improve the Department of Defense's recruitment and retention of tech talent, a skillset we need to address emerging threats like cybersecurity, through the bipartisan **Armed Forces Digital Advantage Act**. She partnered with Rep. Mark Meadows (R-NC) on this legislation, which was enacted into law in 2019.
- Chrissy wrote the bipartisan Securing Americas Rare Earths Supply Act of 2019, which was signed into law in December 2019, requiring the Department of Defense to address our overreliance on China for rare earth materials, which are in everything from weapons systems to cell phones.
- Through the FY21 defense bill, Chrissy was instrumental in pushing the Department of Defense to change the way it calculates financial support for military families living in high cost of living areas that need to pay for childcare off base. This provision became law in January 2021.
- Following the nationwide protests in the summer of 2020 and the President's threat to invoke the Insurrection Act, Chrissy was alarmed by reports of unidentifiable individuals in military-like uniforms and insignia. In order to help distinguish between military, police and civilians in a time of crisis, Chrissy authored a bipartisan amendment to the FY21 defense bill that would require that any individual deployed to respond to a civil disturbance be clearly, visibly identified by agency and name. This legislation became law in January 2021.

# LEGISLATION CHRISSY HAS INTRODUCED

#### IN ORDER OF DATE OF INTRODUCTION

**H.R.8220 — Global Learning Loss Assessment Act of 2020.** This bipartisan, bicameral bill would require the State Department and USAID to assess the impact of COVID-19 on learning loss due to school closures and identifying gaps in distance learning options for students. The bill also requires specific reporting on the learning losses for marginalized populations, like girls.

**H.R. 7931 — PFAS Interagency Research Coordination Strategy Act.** This bipartisan bill responds to the PFAS crisis affecting many communities' drinking water by requiring all Federal agencies to coordinate their research activities to ensure the best use of taxpayer dollars to clean up and replace these harmful chemicals that are found in our water sources. This bill became law in January 2021.

**H.R.7777** — **Paycheck Protection Small Business Forgiveness Act.** This bipartisan, bicameral bill would streamline the process for small businesses to get forgiveness for their Paycheck Protection Program loans under \$150,000. This bill became law in December 2020.

**H.R.7705** — **River Basin Commission Transfer Act.** River Basin Commissions are responsible for leading the coordination of conservation and development of river resources across state lines, and they are funded through state and Federal government monies. In our region, the Susquehanna River Basin Commission and Delaware River Basin Commission look after our waterways. This bipartisan legislation would transfer Federal responsibility for the Commissions from the Army Corps of Engineers to the Environmental Protection Agency, in an effort to ensure that Federal funding contributions to the Commissions' operations are made.

**H.R.7403** — **Protecting Small Business Contracting Opportunities Act of 2020.** This bipartisan bill would help small business contractors better compete for lucrative Federal contracts and requires the Small Business Administration to develop a strategy for ensuring that small businesses owned by socially or economically disadvantaged individuals, women, or veterans or those located in historically underutilized business zones (HUBZones), are competitive for these contracts. This bill became law in January 2021.

**H.R.6822** — **National Public Health Corps Act of 2020.** This bipartisan bill would create a new program under the umbrella of AmeriCorps to use national service volunteers to provide surge capacity for communities during a public health crisis like COVID-19.

**H.R.6583** — To amend title XVIII of the Social Security Act to establish a **risk corridor program for Medicare Advantage plans during the COVID-19 emergency**. This bill would help ensure that older Americans who have Medicare Advantage plans don't see healthcare price increases due to COVID-19. This bill passed the House in May 2020.

**H.R.6388** — Space Technology Advancement Report (STAR) Act of 2020. This bipartisan bill requires the National Space Council to annually report on the ability of U.S to compete with foreign space programs, especially China, and calls on the President to develop a strategy to remain a leader in space technology and economy. This bill became law in January 2021.

**H.R.6307** — **Easing Disruption for America's Small Contractor Act of 2020.** This legislation aims to help small business contractors adversely impacted by COVID-19 by giving them additional flexibility to meet their contract obligations.

**H.R.6051** — **READ Act.** As a former educator, Chrissy has emphasized the importance of foundational literacy and numeracy as the building blocks for education. This bipartisan bill would create a Federal grant program to encourage states to adopt best practices for reading instruction, particularly for students with learning disabilities. This bill awaits action in the House.

**H.R.5353** — Reading Early and Addressing Dyslexia (READ) Act. As a former educator, Chrissy has emphasized the importance of foundational literacy and numeracy as the building blocks for education. This bipartisan bill would create a Federal grant program to encourage states to adopt best practices for reading instruction, particularly for students with learning disabilities.

# LEGISLATION CHRISSY HAS INTRODUCED

**H.R.5238** — **Better and Robust Screening Today (BRST) Act**. This bipartisan, bicameral bill would require the military health insurance, TRICARE, to cover the gold standard of breast cancer screening, 3D mammography or DBT, for women in the military. Thanks to Chrissy's advocacy, the DOD is already temporarily covering this service; this bill would make it permanent. This bill became law in January 2021.

**H.R.4722** — **Support UNFPA Funding Act.** This legislation would restore the U.S. contribution to the United Nations Population Fund, the international organization that is responsible for policy and programming related to women's reproductive health and gender-based violence.

**H.R.4114** — **Stop Supporting Foreign Interference in Our Democracy Act.** This bill would help crack down on foreign interference in our elections by codifying the prohibition on any U.S. person aiding a foreign entity in making an illegal contribution to a U.S. political campaign.

**H.R.3839** — Research Advancing to Market Production (RAMP) for Innovators Act. This bipartisan, bicameral bill would help ensure that entrepreneurs who receive Federal government support through the Small Business Innovation Research (SBIR) and Small Business Technology Transfer (STTR) programs are able to bring their ideas to market. It provides additional funding and support for commercialization throughout the SBIR/STTR process.

**H.R.3769— STEM Diplomacy Act.** Under current regulations, only individuals with certain types of degrees (mainly Bachelors degrees in history, political science, and similar) are able to compete for policy positions at the State Department. This bill would allow STEM professionals to compete, ensuring we have a more diverse pool of applicants working on things like cybersecurity and climate change within our State Department. This bill passed the House in 2019.

**H.R.3639 — Standardizing State Department Parental Leave Act.** This legislation would require the State Department to create standard policies for parental leave across all offices. This bill passed the House in 2019.

**H.R.3638** — Small Business Acquisition Transparency Act of 2019. This bipartisan bill would require that Federal agencies provide unsuccessful bidders on Federal contracts with explanations for why they did not win the contract. This will help small businesses, which spend a lot of time and resources applying for contracts, be more successful competing in the future. This bill was enacted into law in December 2019.

**H.R.3567** — **Securing America's Rare Earths Supply Act of 2019.** Rare earths are in many of the aspects of modern life — both military technology as well as computers and cell phones. However, China controls the majority of the global production of rare earth materials. This bipartisan bill would require the Department of Defense to develop a strategy for securing the supply chain of rare earth materials. It was enacted into law in December 2019.

**H.R.2941** — **Servicewomen's Health Transition Training Act of 2019.** This bipartisan bill would require that every military service develop a specific transition assistance program for women leaving the military to help them prepare for civilian life and to increase familiarity with VA programs. It was enacted into law in December 2019.

**H.R.834** — The Shutdown to End All Shutdowns. Chrissy was sworn in during the longest government shutdown in history, which was a result of failure of Congressional and White House leadership to reach a funding agreement. This bill would prevent government shutdowns and penalize senior leaders in both the Executive and Legislative Branches with docked pay and travel bans in the event of a future failure to reach a budget agreement.

**H.RES.623** — Recognizing and honoring **National Mushroom Day** and the contributions of Chester and Berks Counties to the national mushroom industry.
